Manager for Africa and the Middle East, Competition Division, OECD

Her research and publications explore issues linked to competition, development, critical law and economics, and industrial organization and distribution in the Global South. She also works on the history of law and economics to outline the dialectic relationship between these disciplines through the 19th century onwards. She has advised a number of governments and international organizations on competition law compliance and the assessment of competition law reforms.
